

## Conditions Of Entry

In consideration of the Sporting Shooters Association of Australia, its State, Territory and local Branches, Affiliate Clubs ("The Association") and/or members authorising me to use its firearms ranges, firearms, equipment, services and facilities:

1. I agree to abide by the Association's "Range Rules", as printed at the end of this slip, and any additional local range rules that apply.
2. Except to the extent that SSAA has insurance coverage, I agree:
  - i. Assume all risks arising out of my use of the firearms ranges, firearms, equipment and facilities provided to me by the Association;
  - ii. Release the organisation from all liability no matter how it arises, including negligence, in respect of any injury, loss or damage suffered as a result of my use of the Association's firearms ranges, firearms, ammunition, equipment, services or facilities; and
  - iii. Indemnify the Association in respect of any legal liability it may have to any third party which in any way arises from any use or attempted use by me of any of the Association's firearms ranges, firearms, equipment, services or facilities.
3. I certify that I have never been convicted of a major crime or felony or any offence that would preclude me from legally owning a firearm.
4. I certify that I do not, and have not in the past 12 months, suffered from any mental illness or other disorder which would prevent me from using a firearm legally and safely.
5. I certify that I hold a current firearms licence or permit or have completed a P650 Declaration.

## Sporting Shooters Association of Australia ("The Association") Range Rules:

1. All members and visitors MUST report to the Range Office upon arrival, register and pay the required fees.
2. The Association's Range Officers have total control of the Range.
3. SSAA recommends all shooters and visitors wear eye and ear protection at all times when on the Range.
4. SSAA recommends all shooters and visitors wear enclosed footwear.
5. Children and Junior must be supervised at all times.
6. Firearms must be removed from vehicles in a safe condition. Unloaded with actions open and magazines removed where possible.
7. Firearms are to be carried with muzzles pointed upwards, actions and magazines removed where possible.
8. Shooting is NOT to commence until the "RANGE IS OPEN" order has been given by the Range Officer.
9. When the "CEASE FIRE" order is given ALL shooting will IMMEDIATELY STOP. All firearms are to be unloaded and actions opened.
10. Firearms are NOT to be removed from the firing line until they have been "CLEARED" by the Range Officer.
11. Smoking is not permitted in the vicinity of Black Powder or in Reloading Areas.
12. Anyone considered under the influence of alcohol or drugs WILL NOT be permitted on the Range.
13. In case of a misfire, wait 30 seconds before opening the action. Call the Range Officer if assistance is required.
14. In case of a "live stuck round" or malfunction keep the muzzle pointed down range and advise the Range Officer immediately.
15. Firearms cleaning and adjustments are only allowed in designated areas.
16. There shall be NO HANDLING of firearms during target changes.
